ITServe Alliance PAC - Summary of Litigation Efforts

ITServe PAC and National Leadership Team have been working relentlessly for the past several months and years on matters of utmost importance to our members and beyond. Below, we outlined several of our ongoing initiatives. Our ongoing work will not rest until the below items are addressed and resolved. In addition, our PAC team is constantly monitoring any upcoming issues that may affect our members' businesses. The initiatives below need sustained efforts from our leadership and every member's support and cooperation. Our PAC team has always had an excellent record during the past five (5) years, consistently placing ITServe on the right side of the law.

In addition to our litigation efforts, we're making substantial efforts in DC with our liaisoning initiatives. We need you all to lend your support, voice your concerns during our upcoming <u>CAPITOL HILL DAY</u> on July 13, 2022, and request everyone to sign up and be available to reach out to as many members of Congress (MOCs) as possible.

SUMMARY & UPDATE ON VARIOUS LITIGATION INITIATIVES:

I. H-1 Amendment/Simeo Solutions: It is in front of the judge who ordered mediation with USCIS. We're waiting for a mediation schedule sometime in July/August. While we're not very optimistic that we will settle during mediation, we believe we will ultimately prevail in the courts.

II. 50/50 - \$4,000 Fee Case: We successfully moved past the first of three stages in this case – the presiding judge agreed to move forward with this case based on merits. We're waiting for the second phase of oral arguments from both sides and presenting their views. The third phase is for the judge to decide whether to grant a 'class-action' status.

III. Consular Affairs/Denials: Our attorneys are finalizing the written memo and plan to send it to DOS (Department of State) in Washington DC (which oversees all the consulates in the world) to see if we can have them amicably reverse the client letter requirements (221(g) issuance) at the consulates abroad. In addition, ITServe will also be asking to re-instate the visa revalidation process within the US for H-1 and H-4 visa holders. We expect to have an update in late August.

IV. FDNS Site Visits: Our legal counsel will be reaching out to all Chapters across ITServe to educate & gather information from employees & employers starting in August 2022.

We will be counting on you all to register, join and voice the concerns during our Capitol Hill Day, July 13, 2022, and help build our case.

ITServe intends to support a minimum of 50+ STEM Scholarships to deserving students across the chapters as part of our CSR Programs during 2022.

The qualifying criteria for the scholarships are as follows:

- Highschool graduates enrolling in colleges and/or existing college students for the following year in STEM.
- Minimum 3.0 GPA on a 4.0 scale.
- Have demonstrated unmet financial need as identified by your college or university or partner organization.
- Full-time student enrolled in an accredited college or university.
- Must be enrolled in (STEM) Science, Technology, Engineering, and Mathematics related studies.
- Must have no criminal history.

U.S. Drops COVID Testing for Incoming International Air Travelers

The United States rescinded 17 month old requirement that people arriving in the country by air test negative for COVID-19, a move that follows intense lobbying by airlines and the travel industry. Centers for Disease Control and Prevention (CDC) Director Rochelle Walensky issued a four-page order lifting the mandate.

USCIS to Implement Premium Processing for Certain Previously Filed EB-1 and EB-2 Form I-140 Petitions

U.S. Citizenship and Immigration Services is implementing premium processing for certain petitioners who have a pending Form I-140, Immigrant Petition for Alien Workers, under the EB-1 and EB-2 classifications. This expansion of premium processing only applies to certain previously filed Form I-140 petitions under an E13 multinational executive and manager classification or E21 classification as a member of professions with advanced degrees or exceptional ability seeking a national interest waiver (NIW). Petitioners who wish to request a premium processing upgrade must file Form I-907, Request for Premium Processing Service.
