## PAC UPDATES

#### LITIGATION:

#### 221(g) for Client Letters issued by Chennai Consulate

- ITServe established direct contact at Chennai Consulate and is now attempting to resolve 221(g) directly without submitting client letters. If you are an active and renewed member and received 221(g) from the Chennai Consulate, Please visit this link for the complete message and the information/documents requested to pursue it further
- Upon positive outcome, planning to implement the same with other consulates, the PAC team is hopeful that this can be resolved without litigation.

#### FDNS SITE VISITS:

- ITServe's legal counsel Jonathan Wasden is going around the chapters and educating the members.
- If the FDNS officers ask for any additional information other than what's listed in H1B application, they should let Jonathan know immediately. Most of the officers completely backed off from ALL the information requested after Jonathan's email.
- Some officers are still asking, and Jon is collecting evidential documents from members and will decide our next course of action within the next 60-90 days

#### "50/50" CASE (\$4,000 fee refund for change of status employees picked in the lottery)

• The 50/50 case is in the Federal Circuit Court of Appeals. We have a briefing scheduling order that begins in December 2022.

#### SIMEO SOLUTIONS:

• The Simeio case was argued at the DC Circuit Court of Appeals last month in front of three Judges. Waiting for the outcome, it will be a close call.

#### **CONNECTED PAC:**

GB has identified a Treasurer, Joint-Treasurer, and members for the Connected PAC Board. We plan to complete the process in the next few days.

## PAC UPDATES

#### SYNERGY 2022:

Recognizing ITServe Alliance's move to gain more political power, ITServe hosted two powerful politicians – former President William Jefferson Clinton and former U.N. Ambassador Nikki R. Haley.

- President Clinton, the 42nd President of the United States, led the U.S. to the longest economic expansion in American history, including creating more than 22 million jobs.
- Ambassador Haley, the first minority female Governor in America and the only female Governor in South Carolina history, led the State's unemployment rate to hit a 15-year low. It saw over \$20 billion in new capital investment. As Ambassador, she ensured the American people saw value in their investment, defended U.S. interests, kept our country safe, and championed human rights. For her work at the UN, Forbes named her one of the world's 100 most powerful women.

#### PAC LITIGATION:

In December, ITServe will introduce legislation in the U.S. Congress to help ITServe member companies increase their business and profitability. The legislation, known as the HIRE Act (High Skilled Immigration Reform for Employment), will do the following:

- Enhance the current H1B CAP Quota limits at least 65,000 to 130,000/ year.
- Remove the STEM graduates of U.S Masters Degrees and/or Ph.D. holders from the H1B CAP quota and make it unlimited to retain the top talent & innovation in the Country.
- STEM (Science, Technology, Engineering, and Math) Program to promote the "American Ingenuity Account" to fund State-administered grants for STEM education and worker training.
- H1B Dependent Employer Categorization Relax the requirements.

#### STEM Scholarship Program

ITServe intends to support a minimum of 50+ STEM Scholarships to deserving students across the chapters as part of our CSR Programs during 2022.

ITServe is looking for Universities, Community Colleges, High Schools, and local organizations to partner with and identify the recipients in your communities.

#### The qualifying criteria for the scholarships are as follows:

- Highschool graduates enrolling in colleges and/or existing college students for the following year in STEM.
- Minimum 3.0 GPA on a 4.0 scale.
- Have demonstrated unmet financial need as identified by your college or university or partner organization.
- Full-time student enrolled in an accredited college or university.
- Must be enrolled in (STEM) Science, Technology, Engineering, and Mathematics related studies.
- Must have no criminal history.
- ITServe member companies have an opportunity to award a scholarship in their name of choice by donating \$5000. The scholarship will be named as ITServe -{Name of choice donor} Scholarship.
- Many of our members have expressed interest in awarding STEM Scholarships in the recent past and we are reaching out to you with the induction of this program to have everyone's participation.

ITServe Alliance CSR STEM Scholarships are intended to provide financial assistance to deserving and meritorious students to pursue their STEM education in college.





## **IMMIGRATION NEWS**

### H-1B Electronic Registration Process

In 2020, we implemented an electronic registration process for the H-1B cap. Prospective petitioners seeking to file H-1B cap-subject petitions, including for beneficiaries eligible for the advanced degree exemption, must first electronically register and pay the associated \$10 H-1B registration fee for each prospective beneficiary.
